SIZE ANALYSIS:

THE GROSS SAMPLE WAS WEIGHED AND PASSED THROUGH 10 MM AND 60 MM SEIVES. THE RESULTS OBTAINED ARE AS UNDER:

ONE SEALED SAMPLE HANDED OVER TO MANUFACTURER FOR THEIR RECORD, TWO RETAINED BY SURVEYOR FOR FUTURE REFERENCE AND REMAINING PART USED FOR CHEMICAL ANALYSIS.
